

COURSE DESCRIPTION

The philosophy art for many is something obscure and way too elevated: the somewhat outdated study of the beautiful and the sublime at best. And the philosopher of art a scholar in his ivory tower contemplating rules whose exact meaning and importance the average man in the street will never even fathom. This course has multiple aims: through looking at a variety of art forms and products students will try to look behind this somewhat old-fashioned understanding of aesthetics on the one hand and find methods to propagate a more contemporary and more political study of the arts on the other. And last, but not least, they will learn skills to find out how canonical and non-canonical art production has always been intimately related to each other.

COURSE OBJECTIVES

- a more accentuated and controversial and narrower selection of works and procedures of visual art in and outside institutionalized art history
- reading extensively criticism of art
- reading contemporary theory of art
- discussing canon issues by reading, looking at, listening to and watching art production from a variety of art fields
- writing up experiences with art production in a personal way. Personal does not mean
 psychologizing or overemotional, unsubstantiated. It means that to understand the versatility of
 canons and core values students have to acquire skills in new objectivity and put them to use in their
 own writing.

LEARNING OUTCOMES

- a better understanding of the relations between different branches of art,
- a re-assessment of value, of the core definitions of canon in art, of how the art market operates,

- a critical-theoretical reading of the societal and political factors in art production,
- and eventually an understanding of "There is no common notion of art that necessarily applies to all societies around the world." (Hans Belting).
